Dear Sir,

With reference to the application dated 3.11.1978, I have been directed to convey sanction of the Appropriate Authority for permanent recognition/affiliation of the above said school for All-India Secondary School/Senior School Certificate Examinations of the Board w.e.f. 1.5.1981. The recognition has been granted in pursuance of the Gazette Notification No. 50 dated 1.9.1979 issued by the Govt. of India Ministry of Education and Social Welfare designating this Board as an Appropriate Authority under Delhi School Education Act, 1973 in respect of schools in the Union Territory of Delhi. We may prepare candidates for Board's All-India Secondary School Examination and All-India Senior School Certificate Examination.

The sanction is subject to fulfillment of the following conditions :-

The school shall appoint only qualified and eligible staff;

Service agreement shall be executed and services of any employee of the school shall not be terminated without the prior approval of the Competent Authority;

Service Conditions, Pay & Allowances and other benefits to the employees of the school shall in no way be less than corresponding employees working in Govt. schools of the Union Territory of Delhi.

The school and its records shall be open for inspection by any authorised officer of the Board at any time. The school shall also furnish information as may be asked for by the Board from time to time;

The school shall neither run a profit basis nor earn any advantage to any individual or

6. The school premises or the property shall not be used for commercial, residential purposes (except where staff quarters are there) communal, political or non-educational activities of any kind whatsoever;

7. The rate of tuition and other fees shall not be changed without the prior permission of the competent authority;

8. The admission to the school shall be open to all without any discrimination on the grounds of religion, caste or race, place of birth or any of them;

9. No unrecognised classes shall be run within the premises of the school;

10. The school will help the Board in the smooth conduct of its examinations by placing the necessary accommodation i.e. Halls/Rooms available in the school premises and furniture at its disposal for holding its examinations free of charge, if required to do so;

11. The school will spare sufficient teachers for invigilation purposes at the examinations of the Board as may be required;

12. The school shall follow the instructions laid down by the Board from time to time and abide by all the rules and regulations of Delhi School Examination Act, 1973.
